INFORMATION REQUIRED UNDER ASX LISTING RULE 3.10.5A

Further to the Appendix 3B lodged on 6 May 2015 for the issue of 105,289,474 fully paid ordinary shares (**Placement**), Actinogen Limited (ASX: ACW) provides the following information required under ASX Listing Rule 3.10.5A:

- (b) The Company issued the shares as a placement under Listing Rule 7.1A as it believed that this was the most efficient mechanism for raising funds at the time. The Company had also received an expression of interest from a broker to support the placement making it a more reliable process to fund.
- (c) No underwriting arrangements were in place for the Placement; and
- (d) A fee of 6% totalling \$600,150 (before GST) will be paid to the joint arrangers of the placement, KTM Capital and Forrest Capital, for the amount raised in relation to the Placement.
